

Privacy Policy for Dinner Party

Effective Date: June 23, 2025

1. Introduction

Welcome to Dinner Party, an application provided by Just Joshing, LLC ("Company", "we", "us", or "our"). We are committed to protecting your privacy. This Privacy Policy explains how we collect, use, disclose, and safeguard your information when you use our mobile application (the "App"). Please read this privacy policy carefully. If you do not agree with the terms of this privacy policy, please do not access the application.

We reserve the right to make changes to this Privacy Policy at any time and for any reason. We will alert you about any changes by updating the "Effective Date" of this Privacy Policy. You are encouraged to periodically review this Privacy Policy to stay informed of updates.

2. Information We Collect

We may collect information about you in a variety of ways. The information we may collect via the App depends on the content and materials you use, and includes:

a. Personal Data You Provide to Us:

- Feedback Information: If you choose to provide feedback, we may collect your name, email address, and the content of your feedback message. Providing this information is optional.
- Communication: If you contact us directly, we may receive additional information about you such as your name, email address, phone number, the contents of the message and/or attachments you may send us, and any other information you may choose to provide.

b. Usage Data (Automatically Collected):

- App Activity: We collect information about your interactions with the App, such as features you use, figures you interact with, messages sent, chat duration, frequency of use, and other actions taken within the App. This includes statistics like total messages, unique figures encountered, total chats, and favorite categories.
- Analytics: We use third-party analytics services like PostHog to help us understand your usage of the App and to improve our services. This may include tracking events like settings access, review prompts, feedback form interactions, and screenshot sharing activities.
- Device Information: We may collect information about your mobile device, such as device model, operating system version, unique device identifiers, and mobile network information.
- Error Reporting: We use services like Sentry to automatically collect information about errors, crashes, and

performance issues within the App. This information helps us diagnose and fix problems and may include device state, parts of your application's code, and other technical information related to an error.

- Screenshot Detection: The App detects when a screenshot is taken while using the App to offer you a convenient way to share your experiences. We do not store your screenshots unless you explicitly choose to share them through the App's sharing feature. We may collect analytics data about the usage of the screenshot detection and sharing prompt feature.

c. Information from Third Parties:

- AI Service Providers: The core functionality of the App involves interacting with AI models. While we strive to protect your privacy, interactions with these AI models are processed by third-party AI service providers (e.g., OpenAI). Their use of information is governed by their respective privacy policies. We do not store the content of your conversations with AI figures beyond what is necessary for the immediate functioning of the chat session, unless explicitly stated otherwise for features like chat history (if implemented).

3. How We Use Your Information

Having accurate information permits us to provide you with a smooth, efficient, and customized experience. Specifically, we may use information collected about you via the App to:

- Create and manage your account (if applicable).
- Provide, operate, and maintain our App.
- Improve, personalize, and expand our App.
- Understand and analyze how you use our App.
- Develop new products, services, features, and functionality.
- Process your feedback and respond to your requests.
- Monitor and analyze usage and trends to improve your experience with the App.
- Diagnose and fix technical issues, errors, and crashes.
- Send you push notifications, with your consent, for app updates or other relevant information.
- Comply with legal obligations.

4. How We Share Your Information

We may share information we have collected about you in certain situations. Your information may be disclosed as follows:

a. By Law or to Protect Rights:

If we believe the release of information about you is necessary to respond to legal process, to investigate or

remedy potential violations of our policies, or to protect the rights, property, and safety of others, we may share your information as permitted or required by any applicable law, rule, or regulation.

b. Third-Party Service Providers:

We may share your information with third parties that perform services for us or on our behalf, including data analysis (e.g., PostHog), error reporting (e.g., Sentry), AI content generation (e.g., OpenAI), hosting services, customer service, and marketing assistance. These third-party service providers are obligated to protect your information.

c. Business Transfers:

We may share or transfer your information in connection with, or during negotiations of, any merger, sale of company assets, financing, or acquisition of all or a portion of our business to another company.

d. With Your Consent:

We may disclose your personal information for any other purpose with your consent.

We do not sell your personal information.

5. Data Retention

We will retain your information only for as long as is necessary for the purposes set out in this Privacy Policy. We will retain and use your information to the extent necessary to comply with our legal obligations (for example, if we are required to retain your data to comply with applicable laws), resolve disputes, and enforce our legal agreements and policies. Usage data and analytics data may be retained for longer periods for internal analysis purposes or for improving the security and functionality of our App.

6. Your Rights and Choices

Depending on your location, you may have certain rights regarding your personal information, such as:

- The right to access - You have the right to request copies of your personal data.
- The right to rectification - You have the right to request that we correct any information you believe is inaccurate or complete information you believe is incomplete.
- The right to erasure - You have the right to request that we erase your personal data, under certain conditions.
- The right to restrict processing - You have the right to request that we restrict the processing of your personal data, under certain conditions.

- The right to object to processing - You have the right to object to our processing of your personal data, under certain conditions.
- The right to data portability - You have the right to request that we transfer the data that we have collected to another organization, or directly to you, under certain conditions.

7. Data Security

We use administrative, technical, and physical security measures to help protect your personal information. While we have taken reasonable steps to secure the personal information you provide to us, please be aware that despite our efforts, no security measures are perfect or impenetrable, and no method of data transmission can be guaranteed against any interception or other type of misuse.

8. Children's Privacy

Our App is not intended for use by children under the age of 13 (or a higher age threshold as required by applicable law). We do not knowingly collect personally identifiable information from children under 13. If we become aware that we have collected personal information from a child under 13 without verification of parental consent, we will take steps to remove that information from our servers.
